

## The United Kingdom Imaging and Oncology (UKIO) Congress Attendance Grant Established in 2018

## Introduction

The United Kingdom Imaging and Oncology (UKIO) Congress Attendance Grant is available to qualified members of the Society of Radiographers and to educators who are not radiographers but who promote radiographic education.

The grant is designed to support the presentation of research and/or service evaluation findings as an **oral paper** at the UKIO congress.

Successful applicants will agree to prepare an article for publication in *Synergy* or *Insight* on their experience, and are encouraged to publish the findings of their work in *Radiography*.

**NB** this grant is strictly for oral presentations and is not applicable for poster presentations.

## **Criteria for applications**

Radiographers wishing to be considered for this grant must:

- be based in the UK
- have been in full continuous membership with the Society of Radiographers for a minimum of two years at the date of application for the grant (excluding time spend in student membership)
- hold current registration with the Health and Care Professions Council (HCPC) or appropriate voluntary register
- be working in the clinical setting (those with a split clinical/academic role will also be considered)
- be a first-time proffered paper presenter at UKIO
- be prepared to act as an ambassador for the Society and College of Radiographers during the conference visit and at all times in relation to the receipt and use of the grant
- agree to sign and adhere to the Society and College of Radiographers' terms and conditions for the grant

Educators who are not radiographers wishing to be considered for this grant must:

- be based in the UK
- be a first-time proffered paper presenter at UKIO
- be prepared to act as an ambassador for the Society and College of Radiographers during the conference visit and at all times in relation to the receipt and use of the grant
- agree to sign and adhere to the Society and College of Radiographers' terms and conditions for the grant
- **NB** Unfortunately, we are unable to fund applicants who have previously received UKIO attendance funding.

## **Applications**

Those wishing to apply for the grant are required to submit a conference abstract outlining their work, including how the outcomes of their work are expected to impact patient care. Applications can be made via the online form.

This will be an open, competitive process and those scoring highest with the review panel will be considered for funding.

**NB** Funding will not be released until notification has been received from UKIO confirming that the abstract has been accepted for oral presentation.

The grant will support:

- Full conference registration.
- Accommodation for the duration of the event.
- Return second class rail travel to the conference.
- Subsistence whilst at the event, in line with SoR policy.

Those wishing to apply for the grant are required to complete the <u>online application</u> form and submit by the deadline of **Monday, 17 March 2025**.

The panel will independently assess each application against the award criteria with an aim to notify applicants of outcomes by mid-April at the latest.
